Requesting a special use permit to allow tires and auto repair

P & Z Recommendation

#SUP-20-16: Royal Tyres, Inc. requested a special use permit for the property located at 4984 B.U. Bowman Drive, Suite 107. The special use permit requested is to allow tires and auto repair. The applicant was present and explained the request to the Board. There were no objections from the audience. Motion by Homer Whiting and seconded by Harley Bennett to recommend approval of the special use permit as requested with the following conditions:

- 1. Outdoor storage of automotive parts, junk vehicles or automotive repair related equipment shall be prohibited.

Lee Morgan 6702 McEver Road Parcel: 08-160-001005

Requesting a special use permit to allow mini-storage warehouse

P & Z Recommendation

#SUP-21-02: Lee Morgan requested a special use permit for the property located at 6702 McEver Road. The special use permit requested is to allow mini-storage warehouses. The applicant was present and explained the request to the Board. He stated there would be two (2) two-story climate control buildings up front with an office. The remaining units would be garage bays. They are proposing 400 units. He stated they are proposing a black metal fence along the front with an electronic gate and enhanced landscaping and the remaining fence would be chain link fencing. There were no objections from the audience. Motion by Homer Whiting and seconded by Wayne Johnson to recommend approval of the special use permit as requested with the following conditions:

- 1. All parking and driveway surfaces to be asphalt or concrete with curb and gutter meeting the minimal standards of the City of Buford Development Regulations.
- 2. Entrance limited to one driveway to be compliant with DOT standards.
- 3. Enhanced landscape screening shall be placed along the road frontage and perimeter of the site. Final landscape plan shall be reviewed by the Planning Director. The road frontage shall be contained in a 10' strip offset behind the right-of-way. The perimeter landscape strip shall be a minimum of 5' behind the property line.
- 4. The fence and gate along the frontage of McEver Road shall be a black metal decorative fence with brick columns. The remaining fence along the sides and rear shall be black coated chain link fence.
- 5. The building elevations shall be constructed of brick, stucco or stone on all four sides.
- 6. All drive isles shall be no less than 24 feet width.
